**Background and Expected Outcomes:**

Sustainable Development Goals (SDGs), consisting of 17 goals and 169 targets, were adopted at the 2015 UN Sustainable Development Summit. They are universal goals applicable, not only to developing world but also to developed countries, and are becoming the most important base of the emerging global governance. Welcoming and reacting to this global movement, the Government of Japan established the SDGs Promotion Headquarters headed by Prime Minister Shinzo Abe, and tries to take a whole-of-society approach in implementing SDGs-related policies and activities. In this session, focusing on the Goal 3 (Good Health and Well-being) and Goal 4 (Quality Education), the presenters will discuss Japan's perspectives on international cooperation for the SDGs and future prospects for U.S.-Japan cooperation. As Japan will host the G20 Summit in 2019, the outcomes of the discussion are expected to contribute to that preparatory process.
